NEW ORAL SEDATION REGULATIONS FOR LOUISIANA

From the Dental Organization for Conscious Sedation website:

For patients under thirteen (13) years of age, the administration of more than one agent of any type, including nitrous oxide, shall be considered conscious sedation, and shall require a conscious sedation permit.

In order to obtain a restricted (adults and children) permit to administer conscious sedation with enteral drugs, a dentist MUST submit verification of formal postdoctoral training in the use of enteral conscious sedation on both pediatric and adult patients, or satisfactory completion of a Board-approved course which includes a minimum of 16 hours didactic training and a component on handling emergencies to the administration of conscious sedation.

All dentists must: Utilize a working **pulse oximeter** on patients, and maintain proper **record keeping** mechanism, in addition to a **controlled substance log**.
