EXTENDED LIGHT COMMERCIAL WARRANTY

TuffStuff warrants to the original purchaser that TuffStuff equipment will be free from defects in material and workmanship. All warranty periods begin to run from the date of delivery to the original purchaser. The warranty and remedies set forth herein are conditioned upon proper storage, installation, use and maintenance and conformance with any recommendations of TuffStuff. This warranty does not cover products not manufactured by TuffStuff or products which are altered without the express written consent of TuffStuff.

Extended Light Commercial Warranty:

- A) **Five (5) Years** – Structural Main Frames, Welds, Cams and Weight Plates.
- B) **One (1) Year** – Pivot Bearings, Pulleys, Bushings, Guide Rods, Linear Bearings, Pull-Pin Components, Frame Moving Parts and all other Moving and Mechanical Parts.
- C) **Three (3) Months** – Upholstery, Cables, Finish and Rubber Grips.
- D) **Six (6) Months** – All other parts not mentioned elsewhere in the warranty will expire from the date of delivery to the original purchaser.

The obligation of TuffStuff under this warranty is limited to repairing or replacing warranted defective parts as TuffStuff may elect, at TuffStuff's facility in Chino, California, without charge to the purchaser. Purchaser is responsible for installation of repaired or replaced parts, and all transportation and insurance costs on returned or replaced equipment to and from TuffStuff's facility in Chino.

Requirements:

It is the seller's obligation to disclose the rules and regulations to their customer for the extended warranty to be granted.

- Equipment is to be installed by a TuffStuff certified Dealer.
- Equipment is to be installed by a service company certified by TuffStuff.
- Customer purchasing the equipment understands that the equipment is designed for home use with an extended light commercial warranty.
- Customer purchasing the equipment understands his/her obligations which is to provide proper maintenance, supervision, training, and usage of the equipment, the failure by ignoring any of the above will result in voiding the extended warranty.
- Customer purchasing the equipment is required to post all safety precautions on a bulletin board with easy access to their clientele.
