RESEARCH STANDARD

This Clinical study was conducted in accordance with the International Conference of Harmonization Tripartite Guideline on Good clinical practice, applicable FDA regulations/guideline set forth in 21 CFR Parts 11, and 50 and standard practices of BioScreen Testing services.

CLINICAL SUMMARY OF RESULTS:

Under the conditions of the study of 34 healthy male and female subjects, 36-65 years of age, completed the clinical study evaluating the efficacy of Test Product Regimen: Anti-Wrinkle Serum, Restorative Wrinkle/Eye Treatment, Double Nourishing Sealer, Derma-Lucia's Sun Protector I - 20% Zinc Face Protector SPF 35 and Derma-Lucia's Sun Protector II -BB Sealer Tinted.

1. Skin Hydration by Corneometer

Parameter	Week 8
% of Subjects Improved	97.06%

Clinical Findings:

- **There was a statistically significant improvement in skin hydration from base line at 8 weeks post-treatment.**
- **A statistically significant number of subjects showed improvement in skin hydration from baseline at 8 weeks post-treatment.**

2. **Appearance of Fine Lines and Wrinkles (Periocular) and Skin Tone by Visual grading from Clinical Photography**

Clinical Findings:

- **There was a statistically significant improvement in the appearance of fine lines and wrinkles of the periorcular area from baseline at 8 weeks post-treatment.**

79.41%

Noticed an improvement in evenness of skin tone.

76.47%

Noticed an improvement in skin moisturization/hydration
